### **OVERVIEW**

An Excellence Health Check is a high-level, yet systematic review of an organisation's management processes and their performance against a model of Excellence. It is used to determine the current state of Excellence of an organisation against the guidelines of the Australian Business Excellence Framework (ABEF).

The ABEF provides a model for innovation, improvement and long-term success and is designed to help organisations measure current performance and build a pathway for future success. The ABEF defines 7 Performance Categories that are interrelated. Organisations cannot achieve sustained success without sound systems and processes in place for all 7 categories.

The 7 categories are:

**CUSTOMERS & LEADERSHIP PEOPLE RESULTS** KNOWLEDGE **PLANNING PROCESSES STAKEHOLDERS** 

















An organisation's performance against each Item of the ABEF will be assessed during the Health Check on 4 learning dimensions known as ADRI.

- Approach the intent and desired outcomes
- Deployment how the plan is put into practice
- Results the outcomes achieved
- Improvement the process used by the organisation to continuously improve its results

#### An Excellence Health Check:

Identifies an organisation's key strengths and opportunities

Develops a benchmark maturity rating for the organisation that will allow it to compare its performance over time

Includes an action-planning workshop for the leadership team that will identify the top priorities in achieving the organisational vision

Includes a list of key projects/initiatives/actions that will support the achievement of the vision
